

ORDER ON STUDENT SCIENTIFIC SOCIETY OF THE UNIVERSITY OF TRADITIONAL MEDICINE I GENERAL PROVISIONS

- 1.1 The Student Scientific Society of the University of Traditional Medicine (hereinafter UTM SSS) is a subdivision that units students the aim of which is to promote the scientific, creative and spiritual development of students.
- 1.2 The company operates under the UTM regulation and according to this regulation.
- 1.3 The regulation of company and changes are approved by UTM Scientific Council, with the presentation of the student department.
- 1.4 The company may, in the prescribed manner, have a corner stamp, an official letter;
- 1.5 The Company regulates its relations with the UTM governing bodies according to the UTM Regulation, by the following Regulation and the relevant decisions of the UTM Scientific Council.
- 1.6 The company cooperates with UTM Scientific Department, Student Council, Chairs and other subdivision for its aims and objectives and for implementation of long-term projects.
- 1.7 The name of the company is Ավանդական բժշկության համալսարանի Ուսանողական Գիտական Ընկերություն in Armenia; Студенческое Научное Общество in Russian and Student Scientific Society in English. The abbreviation of the name is ԱԲՀ ՈւԳԸ in Armenia; СНО УТМ in Russian; SSS UTM in English. The address of the company is Babajanyan st. 38, Yerevan.

II OBJECTIVES AND AIMS OF THE COMPANY

- 2.1 The aim of the company is to promote the scientific, creative and spiritual development of students.
- 2.2 The aims of the Company and the main directions of the activity are

- Support and implementation of student initiatives in scientific and educational fields;
- Organization of student scientific-educational presentation, conferences, seminars, popular scientific lectures and other scientific and educational activities, including extracurricular research potential;
- Deliberate use of university youth scientific potential and information system;
- Providing comprehensive support to gifted students;
- Involvement of students in scientific groups and various scientific programs;
- Publication of students' scientific works and other materials;
- Establishment of contact with other scientific centers and exchange of information

III THE STRUCTURE AND THE GOVERNING BODY OF THE COMPANY

- 3.1The governing body of the UTM Student Scientific Society is the Student Scientific Society Council, which meets at least twice a semester.
 - 3.2 SSS Council consists of President, Deputy President and Secretary.
 - 3.3 SSS Council:
 - discusses and determines the most important directions of SSS activity, takes measures to implement decisions;
 - presents suggestions at UTM Scientific Council
 - notes the SSS President's annual report;
 - develops the prospective programs of the company
 - approves its working procedure
 - creates, restructures and resolves SSS work links not defined by this Regulation, as well as approves their memberships and working procedures, and may authorize them to resolve certain issues related to jurisdiction.
 - decides to grant the title of Honorary Member of the Company and regulates other matters concerning the membership of the Company;
 - ratifies contracts and agreements signed on behalf of the company;
 3.4 The work of the UTM SSS is supervised by the Head of the UTM Scientific Division. The company organizes its work with the participation and guidance of the Head of Scientific Part.
 3.5 Session of the UTM SSS is legal if more than half of the total number of members is present.
 Decisions are made by a simple majority of the total number. An Extraordinary General Meeting may be convened at the request of one third of members of the Scientific Council and SSS President.

IV MEMBERS OF SSS COUNCIL

- 4.1 President of Student Scientific Society is approved by UTM Scientific Council for three years.
- 4.2 SSS President is considered as a member of the Scientific Council of UTM
- 4.3 The president of the company represents the company, coordinates the activities of the company board, ensures the cooperation of the structural units of the company, gives power of attorney, concludes contracts and agreements on behalf of the company.
- 4.4The president of SSS makes annual report and represents it at UTM Scientific Council
- 4.5 In case of absence of the Vice President of the Company, he / she assumes his / her authorities, coordinates the activities of the Secretariat and the activities of work links of the SSS Council, and makes a report about the work he has done.
- 4.6 The Secretary of the Company manages the Secretariat's work guided by the working procedure of SSS Council.

V COMPANY RESOURCES AND PROCEDURES FOR THEIR USE

- 5.1The company's funds come from ABC's budget allocations, from donations by sponsors, from other sources not prohibited by the RA legislation:
- 5.2 The Company can use the territorial, proprietary, technical and other means of the UTM for free, in accordance with the established procedure.
- 5.3 Company funds are used in orders to carry out statutory aims and objectives

VI TERMINATION ORDER OF THE COMPANY

- 6.1 The Company terminates its activity in accordance with the procedure established by the UTM Scientific Council or the legislation of the Republic of Armenia.
- 6.2 After the liquidation of the company all its properties and assets will belong to the Traditional University of Medicine.
