ORDER
ON ORGANIZING KNOWLEDGE TEST OF FOREIGN APPLICANTS REMOTELY
OF UNIVERSITY OF TRADITIONAL MEDICINE

I. General provisions

- 1.1. This procedure defines the organization and implementation of the process of admission of foreign applicants remotely (online) to the continuous and integrated educational program of Traditional Medicine University (hereinafter referred to as the University) under in the conditions of the state of emergency.
- 1.2. The legal bases of this order are;
 1. 2020 March 16 decision №298-N "On declaring a state of emergency in the Republic of Armenia" of the Government of the Republic of Armenia.
 2. 2011 Decision N 700-N of April 28, 2006 "On approving the procedure for admission of foreign citizens to higher educational institutions of the Republic of Armenia" of the Government of the Republic of Armenia.
 3. "Internal Order for Admission of Foreign Citizens", this order and other internal documents regulating this order.

II. Applicants' knowledge test

- 2.1. Applicants' knowledge is tested remotely due to the state of emergency declared in the Republic of Armenia using the ZOOM platform that meets the conditions below.
- 2.2. The Knowledge Testing Committee is located in a specially equipped classroom at the University, maintaining social distance.
- 2.3. A maximum of 25 applicants can take the knowledge test per day.
- 2.4. The pre-approved schedule (day, time, names of participants) is sent electronically to all applicants at least 5 days in advance.
- 2.5. Applicants' knowledge test is organized within the framework of the secondary or basic curriculum in the form of interviews or oral exams.
- 2.6. Admission knowledge test is performed;
 - Foreign language (English) required,
 - Biology or chemistry.

- 2.7. Due to the peculiarity of distance learning, it is organized in one format - oral (the ticket contains 3 questions from the preliminary theoretical knowledge).
- 2.8. During the knowledge test, the applicant orally selects the ticket, after which it is placed on the screen.
- 2.9. The applicant is given a maximum of 20 minutes to prepare and answer questions.
- 2.10. The presence of the applicant with a video link is mandatory for the knowledge test. Throughout the examination, the applicant is obliged to keep his/her table and hands in sight.
- 2.11. During the knowledge test, for any reason, in case of turning off the screen or leaving the video, the applicant is given one more opportunity to choose a new ticket, to prepare, to answer new questions. In case of non-satisfaction, the exam is considered not passed.
- 2.12. During the examination, the applicant has no right to use other sources of information; he/she is obliged to maintain academic honesty.
- 2.13. Based on the results of the applicants' knowledge tests, the applicants can be admitted to the first year of the UTM.
